Interest and Penalty Computation

Interest is compounded daily from the due date of the return to the date the tax is paid. Call Taxpayer Assistance at the number listed below to get the current rate.

- A. For failure to file a return on time, with no tax due, the penalty is \$50.
- B. For failure to file a return on time with tax due, the penalty is:
 - 1-60 days late, 10% of the tax due for the first month plus 1% of the tax due for each month thereafter, but in no instance less than \$50,

61 or more days late, the greatest of the following:

- 10% of the tax due for the first month plus 1% of the tax due for each month thereafter not to exceed 30% or the lesser of \$100 or 100% of the tax due, or
