Instructions

General information

Railroad and trucking corporations include corporations, joint-stock companies, and associations formed for, or principally engaged in, the conduct of a railroad, palace car, sleeping car, or trucking business, or formed for, or principally engaged in, the conduct of two or more such businesses.

For tax years beginning on or after January 1, 1998, railroad and trucking corporations are subject to tax under Article 9-A, *General Business Franchise Tax*, or Article 32, *Bank Franchise Tax* (for certain subsidiaries of banks), **unless** they elect to be taxed under Article 9, sections 183 and 184. For more information, see *Filing requirements for railroad and trucking corporations* in Form CT-183/184-I, *Instructions for Forms CT-183 and CT-184*, or see TSB-M-97(8)C, *Railroad and Trucking Corporations Subject to Tax under Article* 9, 9-A or 32 of the Tax Law.

Entering dates — Unless you are specifically directed to use a different format, enter dates in the mm-dd-yy format (using dashes and not slashes).

Election

To be taxed under Article 9, sections 183 and 184, mark an **X** in the box and complete the *Election* section above. To be taxed under Article 9, sections 183 and 184, you must file Form CT-187 no later than the due date (without extensions) of the first return that would be due under Article 9, section 183 or 184; Article 9-A; or Article 32. **This election will remain in effect until revoked by the taxpayer.**

Revocation of election

To revoke an election, mark an **X** in the box and complete the *Revocation of election* section above. You must file Form CT-187 by March 15 of the first year your corporation is not to be taxed under Article 9. The revocation will be effective as of January 1 of that year. A revocation filed after March 15 will take effect the following January 1. This revocation is permanent; once you revoke an election, you may not later elect again to be taxed under Article 9, sections 183 and 184.

Private delivery services

If you choose, you may use a private delivery service, instead of the U.S. Postal Service, to mail in your return and tax payment. However, if, at a later date, you need to establish the date you filed your return or paid your tax, you cannot use the date recorded by a private delivery service **unless** you used a delivery service that has been designated by the U.S. Secretary of the Treasury or the Commissioner of Taxation and Finance. (Currently designated delivery services are listed in Publication 55, *Designated Private Delivery Services*. See *Need help?* below for information on obtaining forms and publications.) If you have used a designated private delivery service and need to establish the date you filed your return, contact that private delivery service for instructions on how to obtain written proof of the date your return was given to the delivery service for delivery.

Privacy notification
