

Tips for Estimated Tax

For assistance, see Form IT-2106-I, *Instructions for Form IT-2106, Estimated Income Tax Payment Voucher for Fiduciaries.*

To help us match the estate's or trust's New York State estimated tax account to the estate's or trust's New York State fiduciary income tax return, and to avoid a delay in processing the estate's or trust's return, please note the following:

Identification number - The identification number of the estate or trust used on these vouchers must agree with the identification number of the estate or trust entered on the New York State fiduciary income tax return (Form IT-205).

Fiscal year filers - If the estate or trust does **not** file on a calendar year basis, enter the dates that the fiscal year begins and ends in *MMDDYYYY* format in the designated entry boxes.

Name - Make sure that the name of the estate or trust is spelled correctly. The name of the estate or trust entered on these vouchers must agree with the name entered on the New York State fiduciary income tax return filed on behalf of the estate or trust.

Foreign addresses - Enter the information in the following order: city, province or state, and then country (all in the *City, village, or post office box)*. Follow the country's practice for entering the postal code. **Do not abbreviate the country name.**

All filers must be sure to **separately** enter the amounts for New York State, New York City, and Yonkers; then enter the total in the *Total payment* box.

Note: If there is **no amount** to be entered for one or more lines, **leave them blank**. If you are entering a whole dollar amount (no cents), enter **zeros** in the cents area to the right of the decimal point.

Do not staple or clip the check or money order to the voucher. Please detach any check stubs before mailing.
