If the amount of tax intended to be evaded is \$1,000 or more, it is a felony under section 1812-f(c)(1) of the Tax Law, punishable by a fine up to \$50,000 or more for an individual or \$250,000 or more for a corporation. I also understand that the Tax Department is authorized to investigate the accuracy of any information entered on this return.
