Whereas, the principal desires not to report on such principal's return for the taxable period immediately prior to the change of residence the amounts referred to in the preceding paragraph which would otherwise be includable under sections 639(a), 639(h), 1307(c), and 1307(f), and

Whereas, the tax for such taxable period prior to the change of residence would have been increased by the amount of \$ _____ if such election had not been made, and

Whereas, sections 639(d), 639(h), 1307(c), and 1307(f) of the Tax Law require a taxpayer to file a bond to secure future payments of tax, calculated on the amount of deferred income as if no change of residence occurred thereunder;

Now, therefore, the condition of this bond is such that if the principal shall pay the full amount of tax, and any penalties and interest thereon, deferred for the year ______ by reason of the election under sections 639(d), 639(h), 1307(c), and 1307(f) of the Tax Law, or shall report for the applicable taxable years all items of income, gain, loss, or deduction, which were accruable for the taxable period immediately prior to such principal's change of residence and which would otherwise have been required to be included in the principal's return for such period, then this obligation is to be void; otherwise, it shall be irrevocable and remain in full force and effect. The obligations of the principal(s) and surety under this bond may not be changed or terminated orally.
