

## Tips for Estimated Tax

**Did you know?** You can pay your estimated tax electronically on our Web site with a debit from your checking or savings account. Visit us on the Web at <a href="https://www.tax.ny.gov">www.tax.ny.gov</a> to pay your estimated tax electronically.

For assistance, see Form IT-2105-I, Instructions for Form IT-2105, Estimated Income Tax Payment Voucher for Individuals.

To help us match your New York State estimated tax account to your New York State income tax return, and to avoid a delay in processing your return, please note the following:

- Social security number/taxpayer identification number Make sure that the social security number used on your vouchers agrees with the number on your social security card and the number used on your New York State income tax return. If you use a taxpayer identification number, this number must agree with the number used on your New York State income tax return.
- Name Make sure that your name is spelled correctly. You should enter your first name, middle initial, then last name in the spaces provided (for example, John O. Smith). Your name must agree with the name on your New York State income tax return.

- Foreign addresses Enter the information in the following order: city, province or state, and then country (all in the City, village, or post office box). Follow the country's practice for entering the postal code.
  Do not abbreviate the country name.
- Married taxpayers Each married taxpayer should establish a separate estimated income tax account. If you and your spouse each maintain an estimated tax account and file a joint New York State income tax return, we will credit the balances of both accounts to your joint income tax return.
- All filers must be sure to separately enter the amounts for New York State, New York City, and Yonkers; then enter the total in the *Total payment* box.

Note: If there is no amount to be entered for one or more lines, leave them blank.

**Do not** staple or clip the check or money order to the voucher. Please detach any check stubs before mailing.
