Rate-per-gallon explanation chart

- .0805 - includes the rates for motor fuel excise tax (.08) and petroleum testing fee (.0005)
- .1845 - includes the rates for petroleum business tax (.184) and petroleum testing fee (.0005)
- .2645 - includes the rates for motor fuel excise tax (.08), petroleum business tax (.184), and petroleum testing fee (.0005)
