- .0805 - includes the rates for motor fuel excise tax (.08) and petroleum testing fee (.0005)
- .1625 - includes the rates for petroleum business tax (.162) and petroleum testing fee (.0005)
- .2425 - includes the rates for motor fuel excise tax (.08), petroleum business tax (.162), and petroleum testing fee (.0005)
