Rate-per-gallon explanation chart

- .0805 - includes the rates for motor fuel excise tax (.08) and petroleum testing fee (.0005)
- .1695 - includes the rates for petroleum business tax (.169) and petroleum testing fee (.0005)
- .2495 - includes the rates for motor fuel excise tax (.08), petroleum business tax (.169), and petroleum testing fee (.0005)
