

Tips for Estimated Tax

Did you know? You can pay the estate's or trust's estimated tax electronically on our website with a debit from a checking or savings account. Visit us on the Web at www.tax.ny.gov to pay the estate's or trust's estimated tax electronically.

For assistance, see Form IT-2106-I, *Instructions for Form IT-2106, Estimated Income Tax Payment Voucher for Fiduciaries.*

To help us match the estate's or trust's New York State estimated tax account to the estate's or trust's New York State fiduciary income tax return, and to avoid a delay in processing the estate's or trust's return, please note the following:

- Identification number The identification number of the estate
 or trust used on these vouchers must be exactly the same as the
 identification number of the estate or trust entered on the New York
 State fiduciary income tax return (Form IT-205).
- Fiscal year filers If the estate or trust does not file on a calendar year basis, enter the dates that the fiscal year begins and ends in mm-dd-yyyy format in the designated entry boxes.

- Name Make sure that the name of the estate or trust is spelled correctly. The name of the estate or trust entered on these vouchers must be exactly the same as the name entered on the federal Form SS-4 filed on behalf of the estate or trust.
- Foreign addresses Enter the information in the following order: city, province or state, and then country (all in the City, village, or post office box). Follow the country's practice for entering the postal code.
 Do not abbreviate the country name.
- Estimated tax amounts Be sure to separately enter the amounts for New York State, New York City, and Yonkers; then enter the total in the Total payment box.

Note: If there is no amount to be entered for one or more lines, leave them blank.

Do not staple or clip the check or money order to the voucher. Please detach any check stubs before mailing.
