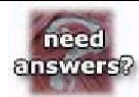

**Welcome to the New York State Tax Amnesty Web site.**

From November 18, 2002 through January 31, 2003-eligible New York State taxpayers had the opportunity to apply for Tax Amnesty and pay their overdue state taxes without penalty charges and at a reduced interest rate. Thousands of individuals and business owners took advantage of the amnesty program to come into compliance and pay their outstanding obligations. Tax Amnesty applicants have until March 15, 2003, or the date specified on their tax amnesty bill (whichever is later) to make full payment.

Although the Tax Amnesty application period has ended, Tax Amnesty applicants may continue to use this Web site to [review their account status](#), [make Tax Amnesty payments](#), [download tax forms](#), compute the amount of interest due with a return under Tax Amnesty (by using the online [interest calculator](#)), [report an address change](#) to the Department, and obtain information about the Tax Amnesty program through the [Answer Center](#).

**Eligible tax periods, uses, or transactions:** [Back to the Top](#)

Except as noted below, tax liabilities for all tax periods ending, or uses or transactions occurring, prior to January 1, 2001, are included under Tax Amnesty. For example, tax year 2000 is the last personal income tax period that qualifies for Tax Amnesty.

In the case of taxes that require the filing of quarterly returns, or an annual return due on the last day of February (e.g., sales tax), the Tax Amnesty program will apply to tax assessments for tax periods ending or transactions or uses occurring on or before February 28, 2001.

Tax Amnesty also applies to estate tax liabilities of decedents with a date of death on or before February 1, 2000.

Mailed applications must be postmarked by January 31, 2003. Online applications

must be submitted by midnight eastern time January 31, 2003. Tax Amnesty payments must be made in full by the later of March 15, 2003, or the date specified on the Tax Amnesty bill or amnesty will be denied. You should consider filing and paying as soon as the Tax Amnesty period begins on November 18, 2002, to stop the accrual of interest charges.

*Prior Tax Amnesty*

A taxpayer who was granted Tax Amnesty under either of the 1994 or 1996-97 New York State Tax Amnesty programs is **not** eligible for those taxes for which Tax Amnesty was previously granted. For example, if Tax Amnesty had been obtained under either of the 1994 or 1996-97 Tax Amnesty programs for a corporation tax liability, the taxpayer is not eligible under the current program for another corporation tax liability. However, the taxpayer would retain eligibility for other taxes. For example, that taxpayer could apply for Tax Amnesty for withholding tax or sales tax.

*Restriction regarding business taxpayers with more than 500 employees*

Business taxpayers are not eligible for Tax Amnesty for the following taxes if they have more than 500 employees, or their combined filing group had more than 500 employees, in the United States on the date of the application for Tax Amnesty:

- Designated taxes under Article 9 (corporation tax)
- Franchise tax on business corporations - Article 9-A
- Tax on petroleum businesses - Article 13-A
- Tax on net income of unincorporated businesses - Article 16-A
- Tax on beverage containers - Article 18-A
- Personal income tax - Article 22
- Unincorporated business tax - Article 23
- Sales and compensating use taxes - Article 28
- Taxes authorized for cities, counties, and school districts - Article 29
- New York City personal income tax - Article 30
- City of Yonkers income tax surcharge - Article 30-A
- City of Yonkers earnings tax on nonresidents - Article 30-B
- New York City earnings tax on nonresidents - Article 2-E

*Civil and criminal actions*

A taxpayer is not eligible for Tax Amnesty for a tax and period in which the taxpayer is a party to a criminal investigation or pending criminal or civil litigation related to such tax and period. However, the taxpayer may apply for all other eligible taxes and periods which are not subject to pending civil or criminal litigation or an ongoing criminal investigation. A taxpayer who has been convicted of a crime related to a tax for which Tax Amnesty is sought is not eligible for any period or assessment for that tax.

The taxpayer may withdraw from civil litigation to obtain Tax Amnesty for a disputed assessment. Also, protest cases before the Bureau of Conciliation and Mediation Services or the Division of Tax Appeals must be withdrawn prior to the granting of Tax Amnesty.

If an application is denied due to an ongoing criminal investigation or pending criminal prosecution, the taxpayer may resubmit the application if these criminal actions do not result in conviction. This resubmission must be within 30 days of official notice that the investigation has been terminated or the conclusion of the prosecution. If the taxpayer has not been officially notified of the termination of a criminal investigation, the resubmission must be within five years and thirty days of the mailing of the Tax Amnesty denial notification.

#### Payments by Mail

##### Electronic Payments:

You must pay your total amount due under amnesty by the later of midnight eastern time, March 15, 2003, or the date specified on the amnesty bill or the Department will deny your Tax Amnesty application. You can pay electronically by one of two methods: electronic funds withdrawal or credit card. Authorized payments cannot be cancelled. Your payment will be effective on the date you charged it.

##### Electronic Funds Withdrawal:

If you have a PIN (personal identification number), you can pay online by authorizing an electronic funds withdrawal directly from your savings or checking account. There is no charge for this transaction. You will need to know your bank account number and the routing transit number of your financial institution.

The funds must be available in your account when you submit your electronic funds withdrawal request. Taxpayers can request an electronic funds withdrawal after using their PIN to log in to secure [Tax Amnesty Online Services](#). You should use the PIN provided on the amnesty mailing received from the Department.

##### Credit Card

You can use your Discover®, Novus® or MasterCard® to pay the amount due under amnesty through a credit card service provider that charges a convenience fee. Personal Income taxpayers may also use Visa® to make a payment.

The credit card service provider charges a convenience fee to taxpayers to cover the cost of providing this service. The provider has an online convenience fee calculator on its Web site. The amount of the fee is determined by the amount of the payment. You will be informed of the amount of the fee before you confirm the credit card fee. If you accept the transaction, you will receive a confirmation number. Retain this confirmation number as proof of payment. The convenience fee and tax payment will appear as two different charges on your credit card statement.

**Payments by Mail:**

Your payment for the total amount due under amnesty, along with your return, must be postmarked by March 15, 2003, or the date specified on the amnesty bill or the Department will deny your Tax Amnesty application.

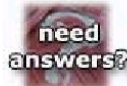

**General Browser Information:**

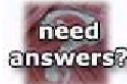
### Disclaimer

The New York State Department of Taxation and Finance ("Department") is committed to providing its customers with the highest levels of service.

As a convenience to our customers, the Department is allowing Tax Amnesty applicants to pay the amounts owed under Tax Amnesty by credit card (via a telephone call or over the Internet).

The Department has made arrangements with a credit card service provider who participated in the New York State tax year 2001 income tax credit card program to provide this service.

Those taxpayers who decide to pay their assessments by credit card over the telephone will initiate the transaction through a Department employee, while those who elect to make a credit card payment over the Internet will do so through the Web site of the selected credit card service provider.



For either method of payment, the taxpayer will need to furnish personal identifying information, the credit card number and expiration date, the amount of the payment and payment application information (such as tax type, tax year, assessment or file reference number, etc.). Also, for either method of payment the credit card service provider will charge a convenience fee to taxpayers to cover its cost of providing this service. However, taxpayers will be informed of the amount of the fee before they confirm the credit card payment.

Taxpayers who decide to proceed with the transaction will receive a confirmation number from either the Department employee or credit card service provider as proof of payment. Taxpayers should also note that, following authorization of the credit card payment, the Department will not retain credit card information for telephone transactions. For Internet transactions, the credit card service provider will forward to the Department only that information necessary for the Department to properly credit the payment to the taxpayer's account (i.e., identifying information, payment amount and application information). For telephone transactions, the Department will not retain any personal credit card information, such as credit card number or account status.

The Department is allowing credit cards to be used for paying Tax Amnesty assessments as a convenience to taxpayers. The decision to use or not to use the products or services offered by the credit card service provider is entirely up to the taxpayer and will not result in any

special treatment from the Department. Further, neither the Department nor the State of New York:

- 1) endorse, recommend or require the use of such provider or its products, processes, information or services;
- 2) make any warranty (express or implied, including the warranties of merchantability, fitness for a particular purpose and non-infringement) with respect to such provider or its products, processes, information or services;
- 3) make any representation with respect to such provider or its products, processes, information or services; nor
- 4) assume any legal liability or responsibility for any act or omission by such provider, or for the accuracy, completeness, timeliness or usefulness of any product, process, information or service offered by such provider.


