Introduction

Article 29 of the Tax Law authorizes counties, cities and some school districts to impose a local sales tax as a complement to the statewide tax. This report presents statistical information on taxable sales and purchases subject to the county or the New York City (NYC) sales tax. Taxable sales include nearly all retail sales of tangible personal property and certain services. Taxable purchases represent the value of tangible personal property or services purchased for use in business operations (which would otherwise be subject to tax) on which no sales tax was previously paid.

This report presents county sales tax data by the state tax base and also by the local tax base for the following items eligible for state tax exemption:

- Clothing and footwear costing less than \$110 (effective March 1, 2000),
- Consumer utility and fuel taxes for residential energy,
- Fuel and utility services and farming services (New York City only),
- Other NYC services (parking services, hotel room occupancy services, cleaning and maintenance services, credit rating and reporting services, miscellaneous personal services, protective and detective services, interior decorating and design services), and
- Services to tangible personal property used in production (expired February 1, 2000). While this local sales and use tax expired at the end of the 1999-2000 selling period, some of the tax collected was not reported until the first quarter of the 2000-2001 selling period.

Unless separately stated, the statistical tables and figures in this publication are based on both the state and local tax base.

Data presented herein are derived from vendor and purchaser information reported on New York State sales tax returns. This publication presents (1) five year statewide annual trends, (2) state and local tax base trends for the two most recent annual selling periods, (3) regional trends, and (4) sales tax activity by industry for New York City and counties outside the City. Each county data table also contains annual state and local base sales tax information by industrial classification for the most recent two years. Data for the March 1999 through February 2000 selling period are revised from the last report. Data for the March 2000 through February 2001 selling period is preliminary and will be revised in our next report.

Recent legislation provided counties the option of exempting some clothing and footwear sales from local sales tax during the March 1999 through February 2000 selling period. During the weeks of September 1-7, 1999, and January 15-21, 2000, clothing and footwear that sold for less than \$500 was exempt from tax in counties that chose the exemption. The majority of counties elected to participate in the temporary clothing exemption program.

On March 1, 2000, the State's permanent sales and use tax exemption on clothing items and footwear costing less than \$110 went into effect. The preliminary data for the first year of this permanent clothing exemption appears in this report. This exemption does not apply to any locally imposed sales and use taxes unless the county or city imposing those taxes elects to provide for it. Fourteen counties and New York City elected to also exempt locally imposed sales and use taxes. Appendix D shows the counties that elected to exempt the locally imposed sales and use taxes and the rates imposed by those counties not electing to exempt local sales tax.

On May 15, 2000, Chapter 63 of the Laws of 2000 was enacted. This legislation amended the Tax Law to provide certain tax benefits under the new "Empire Zones Program Act" which is applicable to the New York State and local sales and compensating use taxes, as well as to certain other taxes. Beginning March 1, 2001, certain purchases and uses of tangible personal property and services by a Qualified Empire Zone Enterprise (QEZE) are exempt from the New York State 4 percent sales and use tax. The exemptions do not apply to any locally imposed sales and use taxes unless the county, city, or school district imposing those taxes elects to provide the exemptions.

Annual Sales and Purchases

Table 1 summarizes annual sales and purchases subject to use tax for all New York counties during the past five years for the state and local tax base. During this period, annual sales grew each year when compared with sales reported for the previous year. Preliminary data for March 2000 through February 2001 indicates that reported sales grew to \$218.8 billion, a 5.6 percent improvement from the previous year.



Figure 1 depicts that the March 2000 - February 2001 selling period continued the upward trend of annual sales that has been underway since the March 1996 through February 1997 selling period. As a result, total taxable sales and purchases now stand 25.5 percent higher than the value posted five years ago.

Industry Analysis

Table 2 provides a look at statewide annual total taxable sales and purchases by industry for the state tax base. Taxable sales and purchases for the March 2000 through February 2001 annual selling period reached \$199.9 billion. This amount exceeds the total reported for the previous year's comparable twelve-month selling period by .8 percent (\$1.6 billion).

Statewide, all of the major industries, with the exception of the retail trade and health care industries, realized year-over-year growth for the latest annual selling period. The most significant increases were in the utilities industry (21.5 percent) and the professional, scientific, and technical industry (13.1 percent). Percentage increases for the remaining major industry groups ranged from 3.9 percent in the arts, entertainment, and recreation industry to 9.9 percent in the construction and wholesale trade industries.

Retail sales accounted for 44.8 percent of state tax base taxable sales and purchases, contributing \$89.5 billion to the statewide total. During this most current selling period, retail sales dropped 8.2 percent from the previous year. This decline is a direct result of the State's permanent sales and use tax exemption on clothing items and footwear costing less than \$110 that went into effect on March 1, 2000. All four sectors associated with the sales of clothing items and footwear (clothing, sporting goods, hobby, book and music stores, general merchandise, and miscellaneous retail) realized a drop in reported sales. The clothing sector (-56.1 percent) experienced the greatest decline while the miscellaneous retail sector only fell by 1.8 percent. Within retail sales, gasoline stations (15 percent) reported the largest percentage increase in sales, due to the 25 percent increase in motor fuel prices from the previous year. Percentage growth in the remaining sectors ranged from 0.7 percent in the health and personal care sector to 7.7 percent in the building materials and garden equipment sectors.

Figure 2: Statewide Industry Shares for the State Tax Base in the 3/00 - 2/01 Selling Period




Figure 2 shows the statewide share of taxable sales and purchases contributed by major industry for the state tax base in the latest selling period. Retail trade and accommodations and food services continue to be the two largest sources of State taxable sales and purchases. Combined, they contribute more than 56 percent of the State total.

Table 3 provides a look at the statewide annual industry totals for the local tax base portion of taxable sales and purchases. These are taxes imposed only at the county or New York City level and are exempt from state tax. Taxable sales and purchases for the March 2000 through February 2001 selling period increased by 111.8 percent. Taxable sales and purchases reported from the 1.5 percent sales tax on residential energy, coupled with the taxable sales and purchases realized by the clothing sector contributed 90.7 percent to the statewide local tax base.

Regional Trends


All but four of the State's counties showed year-over-year gains in taxable sales and purchases. Figure 3 provides a glimpse of regional sales activity. As shown, year-over-year gains were widely dispersed throughout the State.

Table 4 indicates that four counties led the way in reporting double digit growth in total taxable sales and purchases for the March 2000 through February 2001 period as compared to the previous year. Ulster county (11.0 percent) experienced the most growth in taxable sales and purchases, followed closely by Yates (10.7), Orange (10.7), and Saratoga (10.6) counties.

Ulster county reported gains in all its major industry sectors. The most significant percent gain was in the health care industry (21.3 percent) but the real impetus for Ulster's reported gains was in the retail trade industry where significant increases were reported in the clothing industry after the enactment of the State's permanent sales and use tax exemption of clothing and footwear costing less than \$110. Total clothing sales were up 186 percent. Ulster was one of 43 counties that did not elect to exempt local sales tax. Ulster also experienced significant growth in the sales of electronics and home appliances (114.1 percent.) Of the remaining industries, the largest growth occurred in the construction (12.6 percent), and manufacturing (12.4 percent) industries.

Gains reported by the clothing sector of the retail industry, the information industry and the manufacturing industry were the major sources of Yates county's 10.7 percent increase in taxable sales and purchases. Much of the gain in the information industry (99.6 percent) was attributed to increased sales and purchases related to wireless telecommunication carriers, especially during the September–November 2000 quarter. Similar to Ulster county, Yates county saw significant gains in the clothing sector when the State's permanent clothing exemption went into effect. Slight declines were observed in the arts, entertainment, and recreation, accommodation and food services, and utilities industries.

Orange (10.7 percent) and Saratoga (10.6 percent) counties experienced substantial gains in taxable sales and purchases largely due to reported increases in the local sales tax generated from clothing sales and retail sales from gasoline stations, building materials and garden equipment, and motor vehicles and parts.



Slight declines in the taxable sales and purchases in Rockland county (-0.4 percent), Chautauqua county (-0.5 percent), Oswego county (-1.2 percent), and Schuyler county's (-1.5 percent) appear to be mainly attributable to a decrease in taxable sales and purchases in the retail trade industry. These counties, along with ten other counties and New York City, elected to exempt the locally imposed sales and use tax when the State's permanent sales and use tax exemption went into effect.

New York City

The five New York City counties of the Bronx, Kings, New York (Manhattan), Queens and Richmond represent almost 39.6 percent of all reportable statewide taxable sales and purchases for the latest annual period. New York City's taxable sales continue to grow slightly faster than the State as a whole. Year-over-year, New York City's taxable sales and purchases rose 5.7 percent. Similar to the State's economy, New York City sales have continually expanded since the early 1990's, growing from \$65.6 billion in 1996-1997 to \$86.3.

Figure 4: Five-Year Trend (New York City) (In Billions)




Table 6 summarizes New York City's annual total taxable sales and purchases by industry for the state tax base. For the most recent selling period ending February 2001, sales tax vendors reported \$79.2 billion in New York City taxable sales and purchases, an increase of 3.1 percent over the same period one year earlier.

For both the State and City, retail sales provide the largest share of all state base taxable sales and purchases. However, while retail sales represent 44.8 percent of all taxable sales statewide, they represent only 31.8 percent within the City. This disparity reflects the greater importance of taxable services to New York City's sales tax base.

The utilities industry posted the largest percentage increase, rising 33.9 percent from the previous year. Other industries that experienced high growth include the wholesale trade (14.2 percent), professional, scientific, and technical (13.5 percent) and construction (13.2 percent) industries. Gains were also reported for all of the remaining major industries with the exception of the retail trade (-12.7 percent) and health care (-7.4 percent) industries. Retail trade's decline is a direct response to New York City's election to not impose a local sales and use tax when the State's permanent exemption on clothing items went into effect on March 1, 2000.

Table 7 summarizes the local tax component of New York City's taxable sales and purchases. New York City reports taxable sales for two industries not taxed by New York State or any county. The first industry sector includes 1) fuel and utility services used in the production of property for sale and 2) installation, repair, and maintenance services to property used in farming. (Effective November 1, 2000, only fuel and utilities used in the production of gas, electricity, refrigeration, and steam remain taxable.) The second industry sector includes parking services, hotel room occupancy services, and miscellaneous services (cleaning and maintenance services, credit rating and

reporting services, and interior decorating and design services). Taxable sales and purchases reported from the 1.5 percent sales tax on residential energy comprise 75.4 percent of New York City's local tax base. New York City opted not to impose a local sales tax on clothing when the State implemented the permanent sales and use tax clothing exemption and during the temporary clothing exemption weeks.

Counties Outside New York City

Preliminary data indicate that taxable sales and purchases in counties outside New York City reached \$132.4 billion for the year ending February 2001 (Table 8). This value represents a 5.6 percent increase from the previous year and a 21.8 percent increase from sales reported five years ago. As depicted in Figure 5, the five-year trend in taxable sales and purchases reported outside of New York City is similar in direction to the New York City totals.



Analysis of the state tax base industry data presented in Table 9 reveals that the professional, scientific, and technical industry (12.4 percent) reported the largest gain for major industries from the same period in the previous year, followed by the utilities industry (11.7 percent). Following the pattern of New York City, the only two industries to show a decline were the retail sales (-6.3 percent) and health care (-6.5 percent) industries. Within retail trade, sales from the gasoline stations sector (17.3 percent) saw the most significant gain.

Table 10 provides a look at the annual industry totals for the local tax base portion of taxable sales and purchases for counties outside of New York City. Taxable sales and purchases for the March 2000 through February 2001 selling period increased by 191.8 percent, primarily due to the local sales tax on clothing imposed by those counties not electing to exempt it. Taxable sales and purchases from the 1.5 percent sales tax on residential energy together with the local sales tax collected on clothing sales contributed 99 percent to the local tax base for all counties outside of New York City.

Methodology and Data Limitations

The taxable sales and purchases statistics presented in this report come from more than three million data items reported on over three hundred thousand sales tax returns filed each quarter with the New York State Department of Taxation and Finance. The year-ending sales tax quarter that closes on February 28 involves an additional 250,000 returns from taxpayers filing annual returns only. The report aggregates quarterly data into annual periods to dampen fluctuations caused by vendor late reporting, account reconciliation of prior period activities and amended returns.

This report provides a snapshot of a continuously changing sales tax file. File records are updated daily to reflect late and amended returns and corrected return information. A recent analysis of data corrections to the sales tax file indicates that a minimum time period of two years is necessary to generate the data to produce this report. During this period, vendors file their sales tax returns, including amended and late-filed returns. As the returns are filed, the Department has the tax return data entered onto data files, obtains any missing data, checks for data inconsistencies, corrects the data errors and processes the tax payments with the returns. Only after the Department completes this process, will the file records be ready to serve as the data base for preparing this report.

The data in this publication supersedes information included in earlier reports. Although this report includes information for a 12-month period and an annual percent change is computed, special care should be taken when using this percent change. As noted above, sales tax data are subject to continual revision. A significant part of these revisions relates to vendor over- and under- reporting.

This report generally classifies taxable sales and purchases within industrial sectors based on the vendor-reported industry or the industry code identified on the vendor registration form. These codes, from the North American Industry Classification System (NAICS), are listed with their corresponding numerical ranges in Appendix A.

Classification problems arise when vendors inadvertently misclassify or fail to identify their primary business activity. For example, a wholesaler who also conducts retail sales may not understand to classify the primary business as wholesale trade. Misclassification problems are nearly impossible to remedy.

Some counties tax both residential and nonresidential energy sales. However, New York State and a number of counties that are listed in Appendix B, do not tax residential energy sales. In an effort to present a more accurate representation of the State's taxable sales and purchases base for each county, residential energy sales, local clothing taxable sales, and any other local-based taxable sales and purchases that are exempt from state tax are no longer combined with the state taxable sales and purchases base. Instead, they are presented in a separate table for the local tax base.

Appendix C shows combined State and local sales tax rates in each county and identifies changes that occurred during the most recent reporting period. These data are presented for informational purposes.

Appendix D identifies the counties that elected to exempt the locally imposed sales and use taxes on clothing and footwear. It also provides the rates imposed by those counties not electing to exempt the local sales tax.

Data users are cautioned that industry taxable sales may represent only a portion of industry gross sales. Moreover, the percent of sales that are taxable can vary from period to period. As such, taxable sales may not directly reflect the correct level or trend in aggregate economic activity for the industry.


